

# HELP WANTED

The U.S. House of Representatives has heard a proposal by Morris Udall, Mike Lowry and Won Pat to amend the Alaska Native Claims Settlement Act. Bill HR 1400 is supported by these men and needs your support too.

This bill would provide for an equitable distribution of Alaska land to the 13th Regional Corporation, the only Alaska corporation not presently entitled Alaska land that is due them.

This year the State of Alaska will receive 103 million acres of land. The wilderness systems will receive 124 million acres of land while 44 million acres of land will go to other regional corporations.

The 13th Regional Corporation is only asking for your share, a distribution of between 1 and 2.3 million acres selected from public lands. It will not include any lands selected by the State of Alaska pursuant to Alaska Statehood Act nor will it include any lands selected by other regional corporations.

Bill HR 1400 will establish a 5-member 13th Regional Land Commission consisting of the Secretary of Interior, the Governor of Alaska, a representative of the other 12 regional corporations and 2 representatives of The 13th Regional Corporation.

The 13th Regional Corporation desires and intends on working together to joint venture with other regional corporations in developing the natural resources of the land.

We will request your help in supporting a fair, just and equitable distribution of Alaska Native Lands. It is only from such mutual support and solidarity that we will be able to achieve the goals that are important to us all.
