The Council on Domestic Violence and Sexual Assault expects to have funding available for the provision of services for FY92 (July 1, 1991 - June 30, 1992) in the four categories listed below.

State General Funds for Domestic Violence & Sexual Assault Programs:

Domestic Violence Programs providing services for the victims of domestic violence (their families or perpetrators of domestic violence). Sexual assault programs providing services to the victims of sexual assault and their families. Adult Crisis Intervention/Prevention Programs providing information, education, counseling and referral services to individuals experiencing personal crisis related to domestic violence or sexual assault and to individuals in personal or professional transition, including correctional, half-way houses, outpatient mental health programs and drug or alcohol rehabilitation programs.

Family Violence Prevention Funds (Federal):

Programs funded under this act must prevent incidents of family violence, provide immediate shelter and related assistance for victims and their dependents, and comply with other federal requirements.

State General Funds for Batterers/Anger Control Programs in Correctional Institutions:

The programs are to be provided in Nome, Juneau and Fairbanks prisons. If additional funds are provided, additional programs could be provided.

Batterer/Anger Control Programs are to provide the following services: lethality assessments, history of assaultive behavior, continuum of violence orientation, anger control skills, assertiveness skills, feelings and intimacy skills, communication skills and relaxation and stress reduction skills.

Since the application forms for the prison programs is different than the application for the other three types of funding, please specify if you are applying for funds for a prison program.

Federal Funds for Crime Victim Assistance Grants:

Programs must:

- provide services to crime victims; and
- meet other federal eligibility criteria.

The Council is responsible for identifying underserved victims of crimes (victims of DUI and DWI, survivors of homicide victims, victims of elder abuse, adult survivors of incest or child sexual assault, Native American victims of crime on Indian Reservations and other victims of violent crime) and determine how to serve them, if you believe that the population you plan to serve is now underserved, provide a brief explanation.

To qualify for any of the above funds, an applicant must be a city or borough or other political subdivision of the State, a non-profit organization or combination of these.

I. Statement of Purpose:
 The Yukon Kuskokwim Health Corporation is requesting proposals from qualified respondents to assist in conducting a feasibility study of the Outpatient facilities at the Yukon Kuskokwim Delta Regional Hospital. The study will include the development of a plan for the improved utilization of the Outpatient care facilities.

II. Scope of Service:
 With the assistance of the Project Director and a Feasibility Study Committee the respondent will collect data on current usage of all Outpatient care departments to include - ER, OPD, Walk-in clinic and appointments, Dental, MCH, Eye Clinic, Community Health Aide training and Mental Health; review existing building and space, and most recent "Space and Building" study; interview service providers and consumers for their view of needs; review previous OPD studies; assist each department and between departments to meet set criteria for allocation of space, staff, and funds; and formulate recommendations with related costs for change immediately, within 1 year, and within 5 years.

This position will report to the Project Director. Monthly reports will be required on progress of study. The final written report will include all recommendations. The final report is due on March 29, 1991.

In accomplishing the above, attention will be focused on enhancing the interaction between departments to more smoothly integrate services, the fair representation of employees and patients using the facility, and ensuring that recommendations are realistic and able to be accomplished with available funds.

Site visits adequate to accomplish the above will be required and must be addressed in proposal.
