The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that ALASCOM, INC. (Alascom), a telecommunications utility, has filed three tanff revision (TA219-98, TA220-98, and TA221-98) which are briefly described below.

TA219-98 includes numerous revisions to Section 8, Telex Service, of Alascom's intrastate tariff. Alascom states that the filing provides for changes in regulations and application of charges to reflect the policy of the Federal Communications Commission (FCC) that customer premises terminal equipment is not subject to regulation and should be removed from regulated carriers' tariffs. Alascom also states that the filing makes numerous textual and clarification changes to reflect the new operating environment and includes minimum operation criteria for connection with equipment or channels comparable to those in the interstate tariff.

TA 220-98 includes the creation of a new tariff section, Section 9, Customer Premises Equipment (CPE), and numerous revisions to Sections 4 and 7, Message Telephone Service and Private Line Service, respectively. Alascom states that the CPE offerings in the new Section 9 were taken from Sections 4 and 7 and are subject to the FCC decision in Docket 20828. Alascom also states that in removing the CPE from Sections 4 and 7, the monthly charges for exchange access that traditionally have included telephone sets were reduced so that they no longer include a telephone set.

TA221-98 includes the creation of a new tariff section. Section. 10, Mobile Radiotelephone Service, and revisions to Sections 4 and 5. Message Telephone Service and Message Telegram Service, respectively. Alascom states that the filing includes increases to the rates for Coastal Harbor MF CLass II-B, VHF Class III-B, and radiotelegraph services. Stating that this filing to revise its intrastate tariff. was made in the event that the Alaska Public Utilities Commission would wish a concurrent tariff, Alascom continues that TA221-98 was made in response to a recent FCC ruling that where State Commissions desire that there be tariffs filed before them for the regulation of traffic over maritime coast stations, they may do so, but the jurisdiction would be concurrent with that of the FCC and the rates the same as those on file with the FCC.
