NOTICE OF REPEAL OF GENERAL RELIEF MEDICAL EMERGENCY REGULATIONS

As required by AS 44.62.250, notice is given that, under authority of AS 47.05.010, the Department of Health and Social Services repeated on this date the emergency regulations in 7 AAC 47 relating to the General Relief Medical (GRM) program and portions of 7 AAC 43.005 relating to the Medicald program, which were effective on May 17, 1982, in Register 82, July 1982, and were adopted April 15, 1982.

The General Relief Medical (GRM) program will not be limited to coverage for emergency medical

services, but will continue providing coverage for routine medical services at least through June 30, 1982. The emergency regulations were no longer necessary for the immediate preservation of the public peace, health, safety, or general weifare and were repealed. The original regulations in 8 AAC 47 and 7 AAC 43.005 that were replaced by the emergency regulations were reinstated.

The change to an emergency medical services program took place on Monday May 17, 1982, because the Division of Public Assistance of the Department of Health and Social Services, the agency administering the GRM program, had projected the program would be \$1.5 million short during the fiscal year ending June 30, 1982. On May 18, the Legislature enacted House Bill 549 which provided the \$1.5 million needed to continue providing routine medical services under the GRM program and the Governor signed the bill into law on May 19 as chapter 44, SLA 1982.

With these additional funds, the GRM program will continue to provide coverage for routine medical services until June 30, but it is possible that changes to the program are in part dependent on action taken by the Legislature on Senate Bill 817, In addition, the Medical Care Advisory Committee, the policy committee responsible for advising the Department on the operation of the Medicald and GRM programs, will meet in Juneau on June 4 and 5 to consider alternative courses of action available for managing the GRM program.
