DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES NOTICE OF PUBLIC HEARING TANANA AIRPORT IMPROVEMENTS PROJECT NO. D41812

There will be a public hearing May 9, 1985, at 1:00 p.m. at the City office in Tanana, Alaska.

The hearing is being provided by the Department of Transportation and Public Facilities at the request of Tozitna, Limited, the village corporation for Tanana, and the City of Tanana. The hearing will be conducted in accord with Section 152.117, Federal Aviation Regulations.

The purpose of the hearing is to take testimony from Tanana residents regarding the proposal to improve the airport by resurfacing the runway with gravel, extending the safety area pads, resurfacing the east apron and taxiway with gravel and adding runway lighting during the 1985-1986 construction season. The hearing is also for the purpose of considering the economic, social and environmental effects of the airport improvement project and its consistency with the goals and objectives of such urban planning as has been carried out by the community.

The proposed material source for the project is the Yukon River, opposite the townsite. Dredging gravel from the floodplain of a navigable river will require a Section 10 permit from the Department of the Army, Corps of Engineers. A Section 404 permit from the Corps of Engineers will be needed for placement of fill in wetlands for the safety area extension.

During the hearing, testimony concerning the design of the project will be taken orally. Testimony can also be in writing. To be considered, written testimony must be received at the following address no later than May 19, 1985.
