PHYSICIAN EXTENDER FAMILY PRACTICE

Duties and Responsibilities: Position located at the Kodiak Area Native Association's Medical-Dental Center, Kodiak, Alaska. Provides primary medical care/services for the Native residents of Kodiak and the five other villages. The P.E. will spend a portion of his/her time on itinerant visits to the villages as a member of the Itinerant HealthCare Team (IHCT) providing direct care to village residents; and provides patient care to the designated target population at the mid-level practitioner range under the supervision of the KANA Medical Director who will be the Physician Extender's licensed sponsoring M.D. of record. Requirements: Previous professional experience desired. Must be currently licensed as a Nurse Practitioner or a Physician Assistant in the State of Alaska.

Sealed proposals will be received until 3:00 p.m. August 30, 1983 by the Kodiak Island Borough for providing and installation of playground equipment, bridge, gravel paths and timber steps at New Main Elementary School.

The gravel paths shown are to be excavated 12" filled with a silt free material and the entire playground and paths are to be covered with 3" of 3/8" rejected chip material.

The existing low area will be filled in, leveled and 4 inches of D-1 material placed over the area by another contractor. Late completion by initial contractor will extend completion time but will not be the grounds for additional compensation.

It is anticipated that the contract will be awarded in early September, 1983. A 45 day mobilization for the contractor to obtain the equipment will be followed by a 30 day construction period. No winter down of the job will be allowed. Weather days will be considered on an individual basis if the actual weather is significantly different than the average. Because of the significant problems which exist for the school due to the nonavailability of adequate play area, liquidated damages in the amount of \$200 per day will be assessed for late completion to offset the increased cost of providing adequate supervision.

Total cost is estimated to be approximately \$80,000 - \$100,000. Proposals will be evaluated based on cost, ability to perform and performance time. Quoted prices are to be total costs including but not limited to equipment, site work, shipping, permits, installation and clean-up.

Proposals must include detailed submittals on materials and equipment to be provided including manufacturer's name, model number etc. if other than listed.

The Kodiak Island Borough reserves the right to reject any or all proposals, and to waive any irregularities.

The successful proposer will be required to furnish a contract performance and payment bond for one hundred percent of the contract sum prior to award.

Pursuant to Section 14(c)(3) of the Alaska Native Claims Settlement Act, (ANCSA), 85 Stat. 688, AS 44.47.150(a) and 19 AAC 90.015 of the Municipal Trust Land Regulations, Paug-vik Incorporated, Limited has offered to convey the surface estate of the hereinafter described lands to the State of Alaska, in trust, for any municipal corporation hereinafter established in the Village of Naknek, Alaska:

The surface estate of that certain real property located in Surveyed Township 17 South, Range 47 West, Seward Meridian, Alaska, Section 4: the SW4SE4, the SE4SW4 and a portion of Lot 7; Section 9: Lot 3 and a portion of Lot 2, being situated at the Native village of Naknek, Alaska, more particularly described as follows:

Beginning at Corner no.2 of U.S. Survey 2425, the TRUE POINT OF BEGINNING and corner no.1 hereof; thence N73deg.12'E, a record bearing, a record distance of 209.22 feet to corner no.3 of U.S. Survey 2445 and corner no.2 hereof; thence north to corner no.2 of U.S. Survey 2445 a record distance of 1,610.4 feet; thence continuing north ap-

proximately 190 feet to corner no.3 hereof; thence west approximately 1,950 feet to corner no.4 hereof; thence S11deg.28'17"W approximately 1,370 feet to corner no.5 hereof; thence S74 deg.19'30"E approximately 940 feet to corner no.6 hereof; thence S15deg.40'30"W 297.98 feet to the mean high water mark of the Naknek River and Corner No.7 hereof; thence S74deg.19'30"E 60 feet to corner No.8 hereof; thence N15deg.40'30"E 297.98 feet to corner no.9 hereof; thence S74deg.19'30"E approximately 1,150 feet to the intersection with line 2-3 of U.S. Survey 2425 and corner no.10 hereof; thence N8deg.32'W, a record bearing, approximately 80 feet to corner no.2 of U.S. Survey 2425 and corner No.1 hereof, the TRUE POINT OF BEGINNING. This tract contains 83 acres, more or less.

The approximate bearings and distances are subject to redescription upon actual survey. Adjustments or exclusions may be required to conform with the boundaries of any parcels adjacent to or within the land that may be conveyed by Paug-vik Incorporated, Limited under the provisions of Section 14(c)(1), (2) and (4) of ANCSA.

Pursuant to AS 44.47.150(a) and 19 AAC 90.015, the Municipal Land Trust Officer, acting on behalf of the Commissioner of the Department of Community and Regional Affairs, has decided to accept the above referenced offer in partial fulfillment of the obligation of Paug-vik Incorporated, Limited under Section 14(c)(3) of ANCSA. This decision was reached after consultation with the residents of Naknek, Alaska assembled in a village meeting; upon weighing the best interests of those residents and any municipal corporation which may be hereinafter established in Naknek and upon an application of the standards in 19 AAC 90.020.

On June 29, 1983, the residents of Naknek assembled in a village meeting adopted a resolution requesting the Commissioner of the Department of Community and Regional Affairs, acting as trustee for the future municipality of Naknek, Alaska, in accordance with AS 44.47.150(b) to grant a lease for the parcel described above to the Bristol Bay Borough for the construction and operation of a sewage lagoon.

In accordance with 19 AAC 90.430 and .440, the Commissioner approves the subsequent disposal of an interest in said parcel to the Bristol Bay Borough for the aforesaid purpose by the Department of Community and Regional Affairs. This notice is being posted and published in accordance with the requirements of 19 AAC 90.015

(3) .420 and .910. The decision becomes final upon the expiration of 30 days following the publication of this notice, or after 30 days of continuous posting of this notice, whichever is later, unless the decision is appealed to the Commissioner in accordance with 19 AAC 90.940.
