Alaska Native Claims Selection

The purpose of this decision is to modify the Decision to Issue Conveyance (DIC) dated August 26, 1982, and published in the FEDERAL REGISTER on August 26, 1982, pages 37696 through 37699. The DIC included a final determination as to easements and navigability as recommended in the Alaska State Director (SD). BLM memorandum dated March 25, 1982, for the village of Deering.

On October 12, 1982, an amendment to the SD memorandum of March 25, 1982, was issued which identified an additional easement to be reserved. Therefore, the DIC, dated August 26, 1982, is modified to include the following:

Page 37696:

Add the following easement:

- (EIN 10 C5) An easement fifty (50) feet in width for an existing access trail from Federal Aid Secondary Route No. 1510 in the NW 1/4, Sec. 34, T.6N., R. 21 W., Kasei River Meridian, southerly, generally paralleling the Pinnell River to public land. The uses allowed are those listed for a fifty (50) foot wide trail easement. Large all-terrain vehicles (greater than 3,000 lbs. Gross Vehicle Weight), track vehicles, and four-wheel drive vehicles will be limited to winter use only.

In accordance with Departmental regulation 43 CFR 2650.7(d), notice of this modified decision is being published once in the FEDERAL REGISTER and once a week for four (4) consecutive weeks in the TUNDRA TIMES.

Any party claiming a property interest in lands affected by this decision, an agency of the Federal government, or regional corporation may appeal the decision to the Interior Board of Land Appeals, Office of Hearings and Appeals, in accordance with the attached regulations in Title 43 CODE OF FEDERAL REGULATIONS (CFR), Part 4, Subpart E, as revised. However, pursuant to Public Law 96-487, this decision constitutes the final administrative determination of the Bureau of Land Management concerning navigability of water bodies. If an appeal is taken the notice of appeal must be filed in the Bureau of Land Management, Alaska State Office, Division of ANCSA and State Conveyances (960), 701 C Street, Box 13, Anchorage, Alaska 99513. Do not send the appeal directly to the Interior Board of Land Appeals. The appeal and copies of pertinent case files will be sent to the Board from this office. A copy of the appeal must be served upon the Regional Solicitor, 701 C Street, Box 34, Anchorage, Alaska 99513.

The time limits for filing an appeal are:
