Notice of Fund Availability

Emergency Housing Assistance Grants

The ALASKA HOUSING FINANCE CORPORATION (AHFC) announces the availability of approximately \$108,000 for Emergency Housing Assistance Grants (EHAG). Eligible applicants are local governments, government agencies, regional housing authorities or non-profit organizations. The funds must be used to meet the emergency housing needs of homeless persons. Only one grant per community will be made. Communities that have already been awarded EHAG grants in FY96 include Bethel, Juneau, Ketchikan, and Unalaska. **Applications will be accepted until Monday, May 6, 1996.** Grants will be awarded on a competitive basis.

Applicants must demonstrate that an unanticipated emergency situation exists which could not have been included in the applicant's local plan, such as unexpected closure of the area's main source of employment; a natural disaster such as flood, fire, or earthquake; an unexpected influx of new residents exceeding the area's housing capacity, etc. Communities previously receiving funding from this program must also demonstrate that the emergency is materially different than the emergency situation for which funding was awarded.
