

**NOTICE
OF UTILITY
TARIFF FILING**

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that ALASCOM, INC. (Alascom), a telecommunications utility, has filed a tariff revision (TA240-98) which is a request to revise its tariff rules on the recording of telephone conversations. Alascom states that the new rules are being proposed to implement recent orders of the Federal Communications Commission (FCC).

In general the new rules provide that recording devices may be used under the following conditions: (1) The equipment must be arranged so that it can be connected or disconnected (switched on or off) at the will of the customer. (2) All parties to the conversation must give prior consent to the recording of the conversation or a distinctive recorder tone, repeated at fifteen second intervals, must be used to alert all parties to the recording.

An additional provision covers telephone call recordings by FCC licensed broadcast station customers.

Alascom's proposed rules also contain exception to the general rule requiring either prior consent or the intermittent recorder tone. These exceptions cover the recording of such items as calls to and from publicized emergency telephone numbers and calls made for unlawful purposes. The exception also covers calls recorded by law enforcement or federal intelligence authorities acting under color of law.

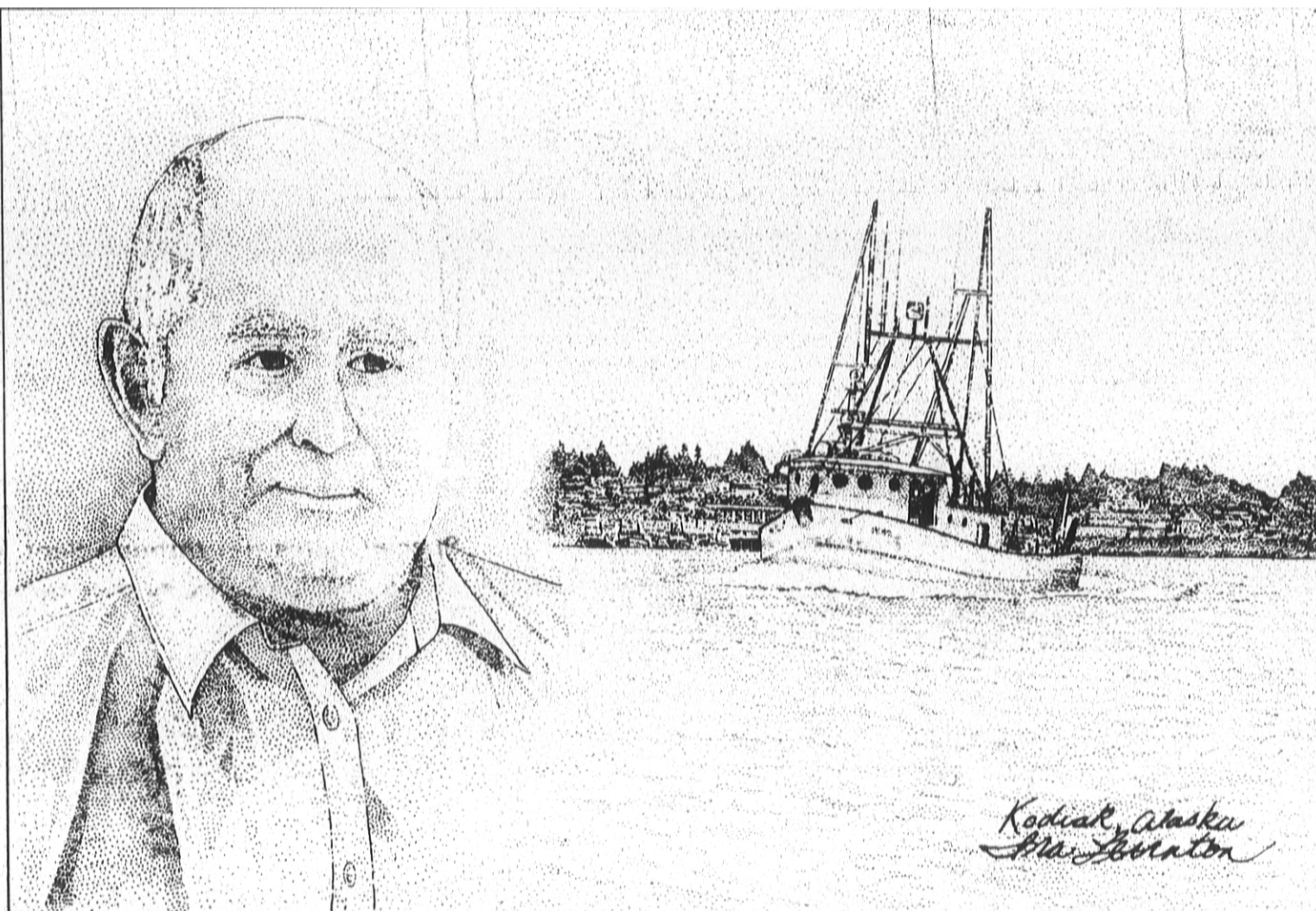
If after investigation the Commission finds a rate or classification different from that proposed by Alascom is reasonable, the Commission may approve a rate or classification which varies from that proposed.

Any interested person may file a statement of views favoring or opposing this tariff filing with the Alaska Public Utilities Commission on or before August 26, 1985. As required by the Alaska Administrative Code; any statement filed with the Commission should clearly affirm that the interested person has filed a true copy of the statement with Alascom.
