TARIFF REVISION  
The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that INTERIOR TELEPHONE COMPANY has filed an application (TA1-165) for a tariff revision consisting of proposed revisions in Tariff Sheets Nos. 2, 3, 42, 43, and 58. The utility states this filing will: redefine "Base Rate Area" to be the area within a one-mile radius of any central office exchange; provide a definition of what constitutes "cost"; and institute a requirement that line extensions into undeveloped tracts or subdivisions be made only on the basis on a special contract. The utility also proposes a monthly charge of \$45.00 for each bush telephone trunk.
