NOTICE OF UTILITY TARIFF FILING

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that the ALASKA EXCHANGE CARRIERS ASSOCIATION, INC. (AECA) has filed tariff revision (TA14-999) to its rules concerning customer obligations for jurisdictional report requirements. According to AECA these rules are being revised "to reflect stricter reporting requirements for Percent State Usage by interexchange carriers to LECs (Local Exchange Companies)."

The jurisdictional report requirements section of AECA's tariff provides that in cases where the telephone company cannot determine the jursidiction of customer traffic the customer may be required to provide an estimate of its traffic, split between the interstate and intrastate jurisdictions.

AECA proposes the following revisions to the jurisdictional report requirements for customers:

- Currently, AECA requires that each customer update its intrastate access minutes report monthly. AECA proposes to require that each customer provide updates to the intrastate (percent usage) and interstate (percent usage) jurisdictional report on a quarterly basis by service and by NXX.
- AECA proposes to add requirements regarding explanation and preparation of jurisdictional reports. One requirement is that the calculated percent state usage be based on the call detail records the customer uses to bill its own customers.
- Currently, if no monthly report has ever been filed, the Telephone Company will assume that the access minutes are 70% intrastate.

AECA proposes that if a customer has not filed two consecutive quarterly reports, AECA may implement the following remedial actions:

- (1) AECA shall estimate what the correct percent state usage should be based upon available billing data.
- (2) AECA shall retain an accounting firm to review the records of the customer to the extent necessary to determine a proper report. Expenses incurred by AECA necessary to implement Step 2 will be billed to the customer.
- (3) AECA will report to the Alaska Public Utilities Commission any remedial action required.
- AECA proposes to add specific procedures and conitions for verifying a filed report, if the Telephone Company, AECA, or the APUC disputes it.
- AECA proposes to add definitions of the terms "intrastate" and "interstate" communication for purposes of determining percent state usage.

If after investigation the Commission finds a rate or classification different from that proposed by AECA is reasonable, the Commission may approve a rate or classification which varies from that proposed.

If you are a person with a disability who may need a special accomodation, auxiliary aid, or service or alternative communication format in order to comment on the proposed tariff revision, please contact Pat Oldenburg at 263-2107 by 4:30 p.m., March 19, 1993, to make any necessary arrangements.

To assure Commission consideration of comments or petitions prior to a final decision on this matter, those comments or petitions must be filed by April 5, 1993. Any statement filed with the Commission should clearly affirm that the interested person has filed a true copy of the statement with AECA.

While comments will be considered by the Commission in determining the appropriate action to be taken, those comments will not serve to make the person a party to the proceeding. Any person wishing to become a party must file a petition to intervene in accordance with 3 AAC 48.110 of the Alaska Administrative Code.
