

TENTATIVE REGIONAL BOUNDARIES

After the chemical structures of marine extracts have been determined and the drugs have been tested successfully in clinical studies, synthesizing their chemical structures will most probably be more economical for producing commercial quantitites than obtaining the drugs from

than obtaining the drugs from natural marine sources.

Introduction of a new drug into clinical use normally requires a period of seven to ten years after its initial discovery. In the case of natural product drugs, the preclinical development alone—detection, isolation, structure determination, pharmacological evaluation, and toxicological studies—may require five to ten years.
