In accordance with 19 AAC 90.430 and .440 the Municipal Land Trust Officer, acting on behalf of the Commissioner of the Department of Community and Regional Affairs, approves of the issuance of a right of entry and the disposal of an electric casement for the above described land to the Nelson Lagoon Electric Cooperative for the aforesaid purpose by the Department of Community and Regional Affairs.
