FAIRBANKS--The Tundra Times erroneously reported on June 14 that Doyon would close an asbestos mine in Canada last month. We erroneously attributed the report to Alaska Industry Magazine.

The report actually came from a Canadian newspaper

Bill Timme, of Doyon, Ltd., told us that the mine which is being closed is sixty miles from Doyon's land, which was selected under the Land Claims Act. There are no mines presently operating on that tract of Doyon's land. The Canadian mine being closed is owned by Cas-sair Asbestos Company, and is in no way affiliated with Doyon.

Dear Fellow Alaskans:

This is an invitation to individuals or organizations to submit a statement on one or more of the 1978 General Election ballot propositions.

As you may know, I am required by law to provide each registered voter with an "Official Election Pamphlet" prior to the November 7 general election. This publication will include information on the candidates, bond questions and ballot propositions.

Each ballot proposition printed in the Pamphlet will include a neutral summary, a statement by persons or organizations supporting the proposition, and one by persons or organizations opposing the proposition. Although I have already contacted the initiative sponsoring committees and legislative opponents and supporters of these measures, I am seeking additional opinions from other informed persons or organizations.

Each statement must be typewritten, double-spaced and no longer than 500 words. Due to the review procedure and printing deadline, I must request a postmark deadline on this material of August 9.

A selection process will result in the printing of one supporting statement and one opposing statement for each ballot proposition. The author's name (and organization, if applicable) will appear in the Pamphlet.

The 1978 General Election ballot will include the following:

1. CSHB 983--"An Act authorizing an advisory vote by the qualified voters of the state on the length of legislative sessions"

CONSTITUTIONAL AMENDMENT

2. HCSSJR 16--"Proposing an amendment to the Constitution of the State of Alaska relating to the work of interim committees of the legislature"

INITIATIVES

3. Initiative No. 6--"An Act relating to the relocation of the Capital of Alaska"
4. Initiative No. 10--"The Alaska Homestead Act"
5. Initiative No. 11--"An Act relating to establishing refundable deposits on beverage containers"

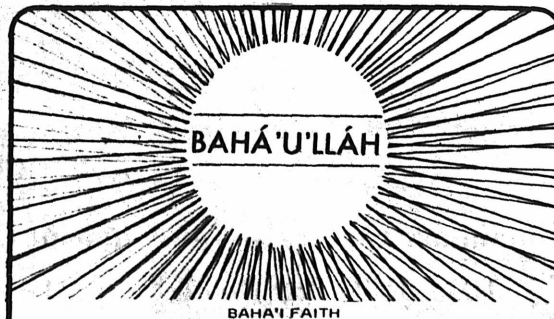
