

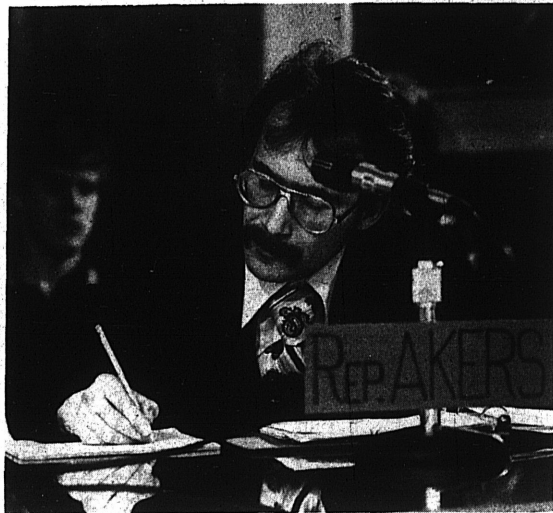
Many in field as political season begins



REP. PHILLIP GUY, Kwethluk, ranking Democrat on the House Finance Committee, is unchallenged in the primary, and will face Republican John Malone of Bethel in the general in District 17.



SEN. KAY POLAND, Democrat of Kodiak is relinquishing her District 1 seat to run for Lt. Governor on the Independent ticket. Seeking her seat are Democrats Ed Naughton and Mike Swetozof and Republican Bob Mulcahy.



REP. BILLY AKERS, of Chuloonawick has no opposition in the Republican primary and is challenged by Democrat Vernon L. Hulbert of Sleetmute in District 18's general election.

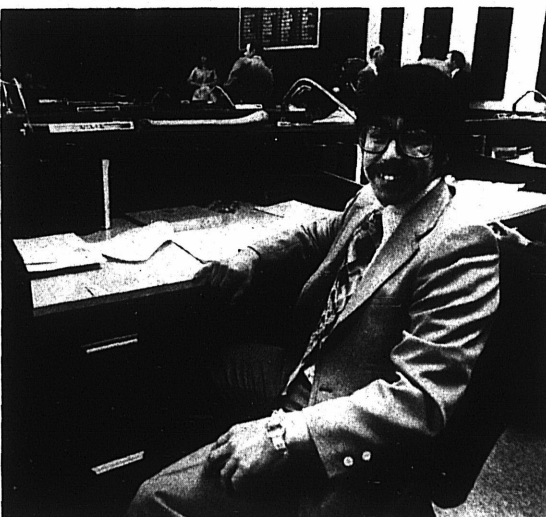
