NOTICE OF PROPOSED CHANGES IN THE REGULATIONS OF THE PUBLIC EMPLOYEES' RETIREMENT BOARD

NOTICE IS HEREBY GIVEN that the Public Employees' Retirement Board, under authority vested by AS 39.35.040, proposes to amend regulations relating to membership criteria for University of Alaska personnel and regulations under the Public Employees' Retirement System.

NOTICE IS ALSO GIVEN that any person interested may present oral or written statements or arguments relevant to the proposed action at a hearing to be held by the Board in the conference room of the Division of Retirement and Benefits on the 6th Floor of the State Office Building in Juneau at 9:00 a.m. on Wednesday, April 10, 1985. Comments will be accepted until then and should be sent to the Division of Retirement and Benefits, Pouch CR, Juneau, AK 99811. Copies of the proposed regulations may be obtained by writing to the Division of Retirement and Benefits at the above address.

This action is not expected to require an increased appropriation, nor is this action governed by the Alaska Administrative Procedure Act. The Board, upon its own motion or at the instance of any interested person, may after the hearing adopt the proposed regulation substantially as described above without further notice or may decide to take no action on them.
