## Chugach selects timber, coal lands Outside

Native Land Claims Act selections made by Chugach Native Inc. recently include as one option thousands of timber and coal producing areas in the Lower 48 states

CNI presented five withdraw. al option selections for land due the corporation under the Alaska Native Land Claims Act to the Chugach Region Study Commission this week. The commission met Tuesday to discuss the withdrawals but made no conclusion

Under ANLCA, Chugach is entitled to 378 000 acres of land or a settlement of equal value lands. The region is able to select lands outside the traditional region because most land in the region is owned by the state or federal government or is on glaciers or mountain tops.

There already has been strong of the options. urging that CNI accept a cash settlement because much of the land in the traditional region is already taken.

- Chugach President Edgar Blatchford said some of the land selections in the Outside were made because they are scheduled to be opened to development soon.

There are 157,000 acres of timber land in Washington and Oregon which are scheduled

Chugach has almost no land now to be opened to cutting and and is seeking high-revenue 56,000 acres of coal producing land listed as "Western coal land" which Blatchford said is scheduled to be opened for development soon.

Timberland in Southeast Alaska also was selected as one

The study group has until Oct. 19 to present a recommendation on what land to give CNI to President Ronald Reagan for action. The study group is composed of CNI, the federal Department of the Agriculture and the Interior and the State of Alaska. Nominations options submitted
