### CALL FOR PROPOSALS

THE ALASKA BOARD OF FISHERIES CALLS FOR PROPOSED CHANGES IN THE SUBSISTENCE, PERSONAL USE, SPORT, GUIDED SPORT, AND COMMERCIAL FINFISH REGULATIONS FOR THE PRINCE WILLIAM SOUND AND SOUTHEAST/YAKUTAT AREAS, AND FOR THE DUNGENESS CRAB, SHRIMP AND MISCELLANEOUS SHELLFISH (all Regions) REGULATIONS

### PROPOSAL DEADLINE — APRIL 9, 1993

The Alaska Board of Fisheries is accepting proposed changes to the subsistence, personal use, sport, guided sport, and commercial finfish regulations for the Prince William Sound (including Sport Fisheries in the Upper Copper and Upper Sustina River Areas) and Southeast/Yakutat management areas. Finfish includes salmon, herring, trout, char, burbot, groundfish, etc.

In addition, the board is accepting proposed changes to the subsistence, personal use, sport, guided sport, and commercial Dungeness Crab, Shrimp, and Miscellaneous Shellfish (including aquatic plants) fisheries for all regions, including the corresponding statewide shellfish regulations.

In order to insure that proposal booklets are distributed well in advance of the board meeting and the fishing season, the board has set an April 9, 1993 proposal deadline. The board realizes that this is an earlier deadline than the public is accustomed to, but feels that more time is needed to insure ample review by advisory committees, regional councils, fishermen's organizations, the public and the department.

### THIRD SUPPLEMENTAL NOTICE OF PROPOSED CHANGES IN THE REGULATIONS OF THE ALASKA BOARD OF FISHERIES

This third supplemental notice supplements the September 15, 1992 and October 7, 1992 notices with inclusion of three agenda changes, an additional statutory requirement, and rescheduling consideration of a Nushagak coho management plan. Under authority vested by AS 16.05—AS 16.10, the Board of Fisheries proposes to adopt, amend, or repeal regulations contained in Title 5 of the Alaska Administrative Code which implement, interpret, or make specific the provisions of the 1992 subsistence law (ch1, SSSLA 1992).

Regulations to be the subject of board action concern subsistence, commercial, guided sport, as well as, sport, and personal use fishing.

The Board of Fisheries may adopt, amend, repeal, or take no action on the subject matter listed in the following informative summary:

#### IN THE BRISTOL BAY REGION

- Deployment of set net gear in the Naknek section of the Naknek/Kvichak District. The board will be considering how the gear will be set/operated, including the position of gear in relation to other gear and to the beaches, and the location of offshore sites in relation to inshore sites. [5 AAC 06.331.]
- Consider providing for set gillnet only openings in the Kvichak section. [5 AAC 06.320.]
- Consider development of a coho salmon management plan for the Nushagak River (Proposal #355) at the January 5, 1993 meeting in Kodiak (Kodiak Westmark Hotel). This matter was previously scheduled for the February 2, 1993 meeting in Anchorage.

#### IN THE BERING SEA - KOTZEBUE AREA

- Consider dates for implementation of the Norton Sound/Herring gillnet mesh depth restrictions. [5 AAC 27.931 (a).]
- The issues described in the preceding informative summaries (except item C.) will be addressed at the following meeting:

#### STATEWIDE

The board will consider implementation of the new statutory direction from the Alaska State Legislature, Ch. 93, SLA 1992, which reads:

"The Board of Fisheries shall adopt by regulation a policy for the management of mixed stock fisheries. The policy shall provide for the management of mixed stock fisheries in a manner that is consistent with sustained yield of wild fish."

The following is to clarify the previous informative summary published on September 15, 1992, for the King/Tanner crab meetings:

#### IN THE KING AND TANNER CRAB FISHERIES IN ALL AREAS OF THE STATE

- In the subsistence, commercial, sport, guided sport, and personal use king and tanner crab fisheries in all areas of the state: establish, amend or delete districts, sections, boundaries, exploratory and fishing areas, fishing seasons and open fishing periods, gear specifications, operations, and restrictions, pot or ring net limits and identification requirements, and pot storage requirements, size and sex limits, guideline harvest ranges, harvest limits and strategies, and bag and possession limits, registration (including exclusive and superexclusive registration and use areas), landing, reporting, operating and onboard observer requirements, management

plans that specify how the fisheries will be managed for the conservation and development of the resources, and how the available harvest will be allocated among beneficial uses and users. Identify customary and traditional uses of specific stocks, convert subsistence fisheries to personal use or sport fisheries, establish personal use fisheries in place of subsistence or sport fisheries, establish personal use, sport, guided sport, and subsistence fisheries, and make adjustments to subsistence, sport and personal use fishing regulations.

- Consideration of a Nushagak coho salmon management plan is rescheduled for the January 5, 1993 meeting in Anchorage.

This action is included in the September 15, 1992 and October 7, 1992 fiscal notes, which estimated an increase of appropriation as follows: FY93 \$137,500; FY94 \$110,000; and FY95 \$95,000.

Notice is also given that anyone interested may present oral or written comments relevant to the subjects in this third supplemental notice as well as the September 15, 1992 and October 7, 1992 notices. Written comments may be submitted to the Board of Fisheries any time before the close of the public hearings at the scheduled meetings. As a practical matter, written comments should be submitted to the Division of Boards office at least three weeks before the scheduled meeting to ensure inclusion in the board workbooks.

The public hearing will begin immediately after staff reports and continue until everyone has been given the opportunity to be heard. Additional public hearings may be held throughout the meeting just before the consideration and adoption of proposed changes in the regulations. An agenda will be posted daily during the meeting. The board will hear oral testimony only from those who register before the start of each public meeting. Oral statements will be limited to five minutes. No comments will be

accepted after the close of the public hearings at the individual meetings. Anyone interested in or affected by the subject matter contained in this legal notice should make written or oral comments if they wish to have their views considered by the board.

Anyone interested in or affected by commercial, guided sport, sport, personal use, and subsistence fishing regulations, is hereby informed that, by publishing this legal notice, the Board of Fisheries may consider any or all of the subject areas covered by this notice. The board is not limited by the specific language or confines of the actual proposals that have been submitted by the public or staff. Pursuant to AS 44.62.200(b), the board may review the full range of activities appropriate to any of the subjects listed. Thus, a proposal regarding setting or changing season or bag limits may require the board to consider any date or any bag limit or not at all. The board may make changes to the commercial, guided sport, sport or personal use fishing regulations as may be required to ensure the subsistence priority contained in AS 16.05.258 is met.

On its own motion, after public hearing, the board may adopt, amend, reject, supplement, or take no action on these matters. In addition, the board may adopt other regulations necessary to implement, administer, or enforce the regulations adopted.

### STATE OF ALASKA NOTICE OF APPLICATION FOR APPROVAL OF THETIS ISLAND UNIT

The Department of Natural Resources gives notice under 11 AAC 83.311 of an application for approval of the Thetis Island Unit Agreement. The proposed exploratory unit area is located on the North Slope to the northwest of the Kuparuk River Unit.

The application was filed with the Division of Oil and Gas on November 13, 1992 by the Exxon Corporation, as the Unit Operator, P.O. Box 4279, Houston, Texas 77210-4279, on behalf of itself and the other Working Interest Owners, Amerasia Hess Corporation, 1201 Louisiana, Suite 700, Houston, Texas 77002-5681, and Chevron U.S.A., Inc., 6001 Bollinger Canyon Road, San Ramon, California 94583-2398.

The Thetis Island Unit Agreement proposes to conform and modify 6 individual State of Alaska oil and gas leases, so that unit operations can be conducted on a unit-wide basis instead of on a lease basis. The six leases cover approximately 25,084.58 acres. Should the Thetis Island Unit Agreement be approved, exploration and development of the unit area would occur in accordance with an approved unit plan of exploration and development.

Approval of the unit agreement would not limit or diminish access to public lands or public or navigable waters beyond any limitations already contained in the individual oil and gas leases proposed to be included in the unit agreement. The Thetis Island Unit Agreement would have a primary term of five years, and would continue so long thereafter as unitized substances are produced in paying quantities, or other unit operations are conducted under an approved unit plan of exploration and development. Leases committed to the unit would not expire so long as the unit remains in effect. The proposed unit agreement has been executed on a State of Alaska Model Unit Agreement form, (Revised April, 1990) with modifications proposed by the applicants and the Alaska Department of Natural Resources.

The proposed modifications include relief from the net profit provisions of the individual leases in exchange for an increase in the royalty rate to 16.6667%, a waiver of the right to earn the exploration incentive credit for which Exxon et al may be eligible under AS 38.05.180(f), and a waiver of the right to request a reduction of royalty under AS 38.05.180(j) until ten years after the start of production from the unit area.

The Working Interest Owners in the Thetis Island Unit proposed to drill three exploratory wells within the unit area in order to evaluate the hydrocarbon potential of the proposed unit area, and to provide geological and engineering data to determine if further exploration and development is warranted in the area. The drilling of the initial exploratory well is scheduled to commence between January and March 1993, and the proposed bottom hole location is within Sec. 19, T14N-R8E-UM. The second well is scheduled between January and March 1995, and the third well is scheduled between January and March 1997. If any of the wells are not drilled as proposed in the unit plan of exploration, the unit agreement will automatically terminate.

T15N, R8E, U.M., Secs. 31-33, 35, 36;  
T15N, R7E, U.M., Secs. 35 and 36;  
T14N, R8E, U.M., Secs. 1-23, 26-30, 34, 35; and  
T14N, R7E, U.M., Secs. 1-3, 9-18

Any person may file written comments on the application. Comments must be received by December 28, 1992, and should be mailed to the Division of Oil and Gas, at the above address, to the attention of Michael D. Kotowski, Units Manager. The Department will review and consider all timely written comments. The Commissioner will approve or disapprove the proposed Thetis Island Unit considering the criteria contained in 11 AAC 83.303, within 60 days after the close of the public comment period.
