Tlingit-Haida Roll Extended to Dec. 31

An extension of the present deadline date of June 30, 1967, for the receipt of the Tlingit and Haida enrollment applications, has been granted by Secretary of the Interior Stewart L. Udall, it was announced by John Borbridge, Jr., President of the Central Council of the Tlingit and Haida Indians of Alaska.

The new deadline date of December 31, 1967, was set in response to a requset presented by the Executive Committee of the Central Council.

Under the provisions of Public Law 89-130, the act that amended the Jurisdictional Act of June 19, 1935, the Secretary of the Interior was "...authorized and directed to prepare a roll of all persons of Tlingit and Haida blood who reside in the United States or on the date of this Canada act."

The deadline date was set by Secretarial regulation and not by statute and was there-
