This comment was made by James Arvaluk, president Inuit Tapirisat (Eski (Eskimo Brotherhood) of Canada, upon learning that the National Executive Council of the Anglican Church of Canada had just passed a strongly-worded resolution condemning recent federal decisions concerning development, and northern development, and asking Ottawa to reverse those decisions.

The Anglican Church leaders in their resolution dealt specifically with the cabinet decision allowing Dome Petroleum to drill for oil and gas under the Beaufort Sea, and with the granting of 68 new prospecting permits covering 12-million acres in the 12-million acres
Northwest Territories.

issuing of the permits as a "deplorable breach of faith" with the Inuit of the N.W.T. comprehensive settlement proposal now in the hands of the government specifically asked that no further permits of licenses be granted until an agreement in principle is

The resolution also notes that these decisions were made "despite the messages of our General Synod regarding development in the north without consultation," and "despite the representations of church leaders to members of the cabinet on March 2, 1976."

Therefore, we call upon the cabinet to reverse these decisions and to abandon the pattern of resource extraction without says consultation," resolution.

In another resolution directed to the church membership, the Anglican leaders praised "the principle, style and integrity of the Berger Commission hearings on the Mackenzie Valley Pipeline." They called on Ottawa to continue to apply the principle of citizen participation in future proposals of profound regional and national impact.

They also urged southern Canadians to understand and accept the issues, and called for active participation in Berger's southern Justice hearings "in support of the need for a moratorium on northern development."

Mr. Arvuluk, attending a meeting of Inuit Tapirisat Directors in Igloolik, said the action by the Anglican Church

leaders reflects growing concern for the rights of Native peoples. He said newspaper editorials and a flood of letters to newspaper editors across the country indicate there is a widespread feeling among Canadians that the government moved too quickly to authorize drilling in the Beaufort Sea, against the advice of its own environmental experts.
