The Rev. Dr. Walter A. Soboleff will deliver the baccalaureate address, "A Kingly Responsibility." He is an evangelist for the Presbytery of Alaska and grand president of the Alaska Native Brotherhood.

The Rev. Bill P. White, pastor of the Church of God, Ketchikan, will offer the invocation and the Rev. William Heynen, pastor of Trinity Christian Reformed Church, Anchorage, will give the benediction.

Music for the program will be provided by the Choir of the North, directed by Prof. Charles W. Davis, and by Mrs. Charlotte Marrow, organist.

## Mary Hale Seeks to Enlist Federal Assistance to Survey Totems in Southeastern Alaska Area

WASHINGTON—Initial efforts to enlist federal as sistance for a survey of totem poles in Southeastem Alaska were made recently by Mrs. Mary Hale of Anchorage, chairman of the Alaska State Council on the Arts.

Sen. E. L. (Bob) Bartlett, D-Alaska, arranged a meeting for Mrs. Hale with Dr. S. Dillon Ripley, secretary of the Smithsonian Institution to discuss participation of the Smithsonian in the survey project.

Mrs. Hale said that the state Council on the Arts was seeking a field survey of all totems and totem fragments remaining in Alaska. She estimated that \$43,000 would be required for the year study.

"In 1938," Mrs, Hale said, "about 160 totem poles in good shape existed in Alaska. Now there are less than 50, as far as we know."

Bartlett, who participated in the meeting with the Smithsonian's chief executive,

"Dr. Ripley was interested in the project. He recognizes the great value of Alaska totem poles to art historians."

"Unfortunately," Bartlett added, "the squeeze on the federal budget plus the lateness of the request makes the prospect of direct financial federal assistance during the budget year beginning July 1 highly doubtful. But indirect participation of the Smithsonian could help immeasurably."

## Boyko Resigns to Seek Legislative Office

Juneau-Gov. Walter J. Hickel announced last week that Atty. Gen. Edgar Paul Boyko has formally submitted his resignation effective June 1.

In a letter to the Govemor, Boyko said, "Considerations of family, and professional career regretably compel me at this time to leave the post I enjoyed so much.

"Because I am seriously contemplating running for legislative office, I feel that my resignation will have to become effective not later than June 1."

Boyko was appointed in June 1967, succeeding Donald A. Burr.

In his letter to Hickel, Boyko commented, "It has been an exciting and stimulating year for me. Serving as the Attorney General in your administration has been an experience I shall never forget.

"You will find the moral e in the Department of Law to be high; its record of achievement during the past year a matter of just pride; its lawyers, secretaries and clerical staff among the best anywhere."

In a reply to Boyko, the Governor said, "You have been a great help to our administration in our efforts to do a good job for Alaska. Our informal brain—sessions on local autonomy, native land claims and the general battle to make Alaska greater will be missed."

No announcement was made as to Boyko's successor. Deputy Atty. Gen. G. Kent Edwards will be acting head of the Department of Law.
