meteorological photos of the study area each day by direct broadcast from NASA satellites orbiting the earth at about 700 miles. Daylight picture will be via a visible wavelength; night transmissions in infra-red wavelength.

Daily routine of oceanographic vessels consists primarily of occupying scientific "stations." Each station entails stopping the ship to collect samples of marine life and sea water for analysis either aboard or at the home laboratory.

Hundreds of such stations, some requiring up to four or five hours, would be necessary to cover an area as large as that shown in a single photograph taken from a satellite.

BCF scientists hope that the broader coverage offered by spacecraft picture transmission, combined with routine oceanographic observations, will provide a more effective and more rapid method of surveying the ocean.

Sealed bids in single copy for furnishing all labor, equipment, and materials and performing all work on Project S-0966(6), Mendenhall Loop Road, Auke Bay to Mendenhall River, described herein, will be received until 11:00 a.m. prevailing time, June 13, 1968, in the Commissioner's Office, Department of Highways, Island Center Building, Douglas, Alaska.

This project consists of grading, drainage, and hot bituminous plant mix surfacing of 2.8 miles of roadway located approximately 12 miles north of Juneau, Alaska. Included in the construction will be a concrete slab bridge 37 feet long with a clear roadway width of 38'-7".
