> Aided by volunteer Eskimo language speakers and conducted by Osahito Miyaoka, Japanese linguist appointed assistant professor Japanese and Eskimo, course will examine structure of the language.

It will be concerned mainly dialects spoken in southwestern Alaska along the Yukon River delta.

This summer, Miyaoka conducted a three-village field study of Eskimo dialect differences, examining the spoken language a tiny village Umkumute, along the southwestern coast; in Anaktuvuk Pass in the Brooks Range, and in Point Hope in northwestern Alaska.

Relationships of the Alaska Eskimo dialects was also the subject of Miyaoka's master's degree thesis at Japan's Kyoto University in 1963.

The linguist graduated from the Osaka University of Foreign Studies in 1959 and has since been employed in the City (Japan) High Kobe School and the Otaru University of Commerce, also in

Two other appointments in the Department of Linguistics and Foreign Languages are Marguerite P. Van Doorslaer, assistant professor of French, and Charles H. Parr, assistant professor of German and Russian.

Dr. Van Doorslaer was formerly an assistant professor of French at Colorado State University. She has also been employed by the University of Texas, Museum of International Art in New Mexico and the University of Michigan.
