E. To promote good government, by reminding those who govem and those who are governed of their mutual responsibilities.
MEMBERSHIP AND ELIGIBILITY TO OFFI CE MEMBERSHIP
Section 1. Active Membership of the Alaska Federation of Natives shall consist of the following: All persons of Eskimo, Indian or Aleut blood extraction, duly enrolled in the tribal rolls of any village or area-wide association of the State of Alaska, or until such tribal roll is established, enrolled provisionally on the temporary tribal rolls of the village or area-wide association. Standards for such temporary enrollment shall be determined by the village or areawide association.
Section 2. The Board of Directors may provide for associate or honorary membership.

ELI GIBILITY TO OFFICE
Section 3. To be eligible for election to any office in the Alaska Federation of Natives, a member must be a minimum age of 19 years, an active enrolled member in good stand ing and must have been a legal resident in the State of Alaska for two (2) consecutive years.

ARTI CLE III
ANNUAL MEETING AND REPRESENTATION
ANNUAL MEETI NG
Section 1. The delegates present at the annual meeting shall be the supreme governing authority of the Federation and shall have the power to regul ate and direct the policies, affairs and organization of the Federation.
Section 2. East OF REPRESENTATION village not a member of an area wide association, in the State of Alaska shall be entitled to one (1) delegate to the annual meeting and one (1) delegate for each additional one húndred (100) enrolled active members beyond fifty (50). Proxy votes will be allowed. A delegate may give his proxy only to another member of the delegation of his area-wide association or village.

REQUISITES FOR REPRESENTATION
Section 3. No village and no area-wide association shall be entitled to representation at the annual meeting which, at the time of the annual meeting, is six months or more in arrears in monies due to the Federation.

EXPENSES OF DELEGATES
Section 4. Each village or area-wide association shall pay the expenses of its delegates to the annual meeting.
Section 5. Each village, or if it has joined an area-wide association, then the area-wide association, shall elect, in delegates to the annual meeting. Villages in the State of Alaska which have combined into area wide association s shall file their constitution with the Federation.

COMMITTEES
Section 6. The following standing committees of the Federation are hereby established:
A. Committee on Committees shall consist of the Directors of the Federation in attendance at the annual meeting and shall appoint all standing committees subject to approval of the annual meeting.
B. The Constitution Committee shall prepare proposed amendments to the constitution of the Alaska Federation of Natives.
C. The Education Committee shall have charge of all matters pertaining to the education of the members and the dissemination of literature and beneficial irand the dissemination of literature and beneic.
formation both to the members and to the public.
D. The Lands Committee shall keep the membership of the Federation advised of the status of Native land claims, and other aboriginal rights of the membershi p.
E. The Health and Welfare Committee shall establish and have charge of programs to promote the health and welfare of the Natives of Alaska.
F. The Grievance Committee

The membership, at its annual meetings, or the President is authorized to create such other committees from the membership as it may determine will facilitate the work of the Federation.

## QUORUM

Section 7. A quorum shall consist of a majority of the delegates elected and present in person or by proxy at any annual meeting.

DATE OF ANNUAL MEETING
Section 8. The annual meeting shall be held at such place as may be designated by the Board of Directors, in the month of October, for the purpose of electing officers and directors and for the transaction of such other business as may come and before the meeting.

## ARTICLE IV <br> OFFICERS

Section 1 (a). The officers of the Federation shall consist of a President, a First Vice-President, a Second VicePresident, a Secretary, a Treasurer and a Sergeant at Arms. The President, First Vice-President, Second Vice-President, Secretary, Treasurer and Sergeant at Arms, will be voting members of the Board of Directors.
Section 1 (b). The Board of Directors shall consist of a member elected by each area wide association and three (3) at large members elected by delegates from villages not included in area wide associations at the regular annual meeting.
Section 1 (c). The Directors shall hold office for a term of two (2) years. Half of the Directors shall be elected annually. The Directors shall hold office until their successors have been elected and have assumed office, official notification to
the Alaska Federation of Natives by mail or telegram will ELECTION OF OFFICERS
Section 2. All nominations and elections for officers of the Federation shall be made at the annual meeting; election
shall be by secret ballot vote. Candidates must accept the shall be by secret ballot vote. Candidates must accept the
nominations in person or in writing. All officers shall be immediately installed and assume their duties.

Section 3. Officers shall hold office for a term of two years.

> SALARIES AND EXPENSES OF OFFI CERS

Section 1 (a). The salary of the President shall be established by the Board of Directors provided that it shall be not less than $\$ 12,000.00$ per year.
Section 1 (b). The President, Vice-Presidents, Secretary Treasurer, Sergeant at Arms and members of the Board of Directors will be reimbursed for out-of-pocket expenses incurred.

## ARTICLE VI

DUTI ES OF OFFICERS
Section 1 (a). The President shall preside at all meeti ngs of the Federation, shall be ex-officio member of all committees, shall preside at all meetings of the Board of Directors, and shall perform all such duties as are incidental to the office of President and are properly required of him.
Section 1 (b). The First Vice-President shall, in the absence of the President, exercise all of the functions of the President and shall be vested with all his powers.
Section 1 (c). The Second Vice-President shall, in the absence of the President and First Vice-President, exercise all of the functions of the President and shall be vested with all of the functions
all of their powers.
Section 1 (d). The Secretary shall have charge of all papers, keep such records, make such reports and perform such duties as are incidental to that office, and properly required of him by the organization.
Section 1 (e). The Treasurer shall have charge of all the funds of the Federation, shall conduct its banking business and audit all accounts. Checks drawn shall be signed by either the President or the Treasurer and shall be countersigned by an additional officer. The Treasurer shall give a bond for the faithful discharge of his duties in such sum as may be determined by the Board of Directors. The Treasurer shall make a written annual fin ancial report, to be presented on the first day of the annual meeting.

ARTICLE VI
BOARD OF DIRECTORS - DUTI ES AND POWERS GENERAL
Section 1. Such powers, duties and authority as are not otherwise delegated to the President and Secretary of the Federation shall be exercised, acted upon, and-determined by the Board of Directors. The Board of Directors shall have the authority to interpret and apply the Constitution and By-Laws of the Federation and to decide all questions of law thereunder subject to appeal to the next annual meeting. The Board of Directors shall have governing authority over the Federation between annual meetings.

MEETINGS OF BOARD OF DIRECTORS
Section 2. The Board of Directors may hold quarterly meet ings at such specific time and place as shall be determin ed by the President. At the discretion of the. President. a quarterly meeting may be held within one (1) month after the end of the quarter. Upon the written request of a majority of the Board of Directors to the President. It shall be the duty the Board of Directors to the President. It shall be the duty

Board of Directors shall constitute a quorum for the transaction of its business.

## ARTICLE VIII <br> REVENUES

Section 1. The revenues of the Federation shall be derived as follows:
A. Charter fee of twenty-five dollars $(\$ 25.00)$ per orgatization entitled to delegates.
B. Each area wide association and village not included in area wide association; shall pledge financial support, according to their ability to pay.
C. The Federation may raise revenues from ther sources. ACTION WHEN NOT IN FORMAL SESSION
Section 2. In all matters requiring action by the Board of Directors, and when the Board of Directors is not in forma session, the Board of Directors may act by telegram, letter or long distance telephone confirmed in writing. When the President requires action by the Board of Directors, he may Presin the same by telegraphing, writing or telephoning to the members of the Board of Directors, and such members may members of the Board of Directors, and such members may
take action on the matter brought to their attention in the same manner; provided, however, that whenever action is sought by any of the foregoing methods, all members of the Board of Directors shall be polled. EMPLOYMENT OF CLERICAL, TECHNICAL AND PROFESSIONAL ASSISTANCE
Section 3. The President shall have the power to employ or retain such clerical, technical and professional assistance as he may from time to time require. Subject to approval of the Board of Directors.

The Small Business Administration through its Fairbanks Disaster Office has approved in excess of 2,000 disate loans since the mid-Augus flood.
Homer E. Davies, manager of the local office, announcer that the Agency had appro-
ved 1,630 home loans and 394 ved 1,630 home loans and 394
business loans for a total of business loans for a total of
2,024 bans through Tuesday, 2,024 bans through
October 24,1967 .
The dollar volume of the 2,024 approved loans now totals $\$ 28,317,455.00$ with $\$ 13,636,946.00$ of that amoun already disbursed to the borrowers. Loan application pending the same date totaled 287 and consisted of 161 home loin applications and
126 business loan applicatnns.
Davies stated that his figures show that many of the persons, suffering disaster loss had availed themselves of the $\$ 3,000$ or less unsecured loan liberalized to that figure following the E. L.
