NOTICE OF UTILITY TARIFF FILING

The ALASKA PUBLIC UTILITIES COMMISSION hereby gives notice that MATANUSKA ELECTRIC ASSOCIATION, INC. (MEA), has filed a tarriff revision (TA12-18) consisting of a general rate increase to all Unalakleet customers. MEA proposes generally a flat 68% increase over the basic 1975 rates, which excludes the present fuel cost surcharge of 1.81% per KWH, or approximately a 50% increase over the present rates, including the fuel cost surcharge. One exception to the flat percentage increase is that the unit charge for the first 50 KWH's used by commercial customers would be increased from the present 20 cent/KWH to 40 cent/KWH with the balance of the Commercial Schedule increasing by 68%.
